TWC planning guidelines suggest that the use of uPVC is to be resisted but 4 Crown View was allowed as are other uPVC applications in The Gorge. So, we resister an objection to the creep of uPVC but acknowledge that precedents have been set. Maybe it is time for a review of the various TWC planning and conservation documents that reference uPVC in the light of new materials and styles and the increasing use of the material in the WHS.
